1. 2. The Status of IEA: Sam Crecelius	<p>2019 was another successful year for IEA. The organization continues to grow and provide opportunities for our members to network, share resources, and enhance knowledge and skills through professional development. Moreover, we continue our efforts to increase the visibility of evaluation to those outside of the field. In October, we hosted IEA's third biennial conference. This was our largest conference to date, with 82 attendees. I believe this was a great success and also provided lessons for the board as we continue to expand what we offer our members.</p> <p>Building on the leadership of Mindy King and Nicole Dunn, my tenure as a board member and, specifically, president has focused strongly on operations and infrastructure. Going into 2020, I believe that IEA has the operational and financial stability to provide a great springboard for the next board of directors to put their vision to action. In 2017, the board chose to move away from contracted administrative services to a working board model. This model has saved IEA thousands of dollars during the last two years, and as you will hear from Elaine later today our financial position is among the strongest that the organization has had. While it has created additional work for board members, this approach has also placed those of us selected by you, the membership to lead IEA directly in the day-to-day operations of the organization. This has allowed greater accountability, stronger governance, and increased efficiencies. To support this work, the board has employed various technological solutions over the years. Building on the functionality provided through our last website, IEA transitioned to the Wild Apricot Membership Management System in Spring 2019. Through Wild Apricot, IEA manages events, membership, communication, and finances through a single system. This has eliminated redundancies, cutting costs and allowed board members to use their time more efficiently. With critical organizational tasks managed by the system, the board will now have a greater</p>

	<p>opportunity to pursue new initiatives and grow the organization. Given the strong infrastructure in place, I look forward to seeing where future boards take the organization.</p> <p>It has been an honor serving IEA as president. Thank you again to everyone who has been a part of IEA during 2019. I want to say a special thank you to my colleagues on the board. We have a wonderful group of talented people who generously volunteer their time keep IEA up and running and most importantly growing. Membership Committee Update: Carolyn Higginbotham - IEA Secretary and Membership & Communication Committee Co-Chair	<p>Current IEA membership is 72 members.</p> <ul style="list-style-type: none"> • 7 Organizational Members (Lumina Foundation and Transform Consulting Group) • 57 Regular Members • 8 Student Members <p>3 Regular Memberships lapsed in September and were not renewed.</p> <p>A priority of the coming year will be to follow up with the lapsed members as well as the 29 non-members who attended the Conference to see if they are interested in joining.</p>
4. Communications Update: Tessa Skidmore – Membership & Communication Committee Co-Chair	<p>As Sam mentioned, the shift to Wild Apricot has streamlined many areas of IEA's operations, including communications, in the past year. In addition to simplifying management of the organization's members and other contacts, the system has facilitated more frequent and targeted communication around events.</p> <p>We feel this functionality, as well as board and committee members' personal outreach to AEA affiliates and other groups, contributed to the record 2019 conference attendance that Sam also mentioned. Although the program committee's efforts to assemble an impressive line up of attractive speakers and sessions should not be overlooked.</p> <p>Much of the Membership and Communication Committee's recent work has centered on marketing the conference, and we cannot thank committee members enough for their contributions. Jennifer will recognize these individuals during her programming update.</p> <p>In 2020, having operationalized day-to-day communication and contact management through Wild Apricot, we are excited to be able to shift our focus to exploring new channels and audiences for member and event outreach. We look forward to leveraging the networks and ideas of our new board members in this endeavor.</p>
5. Program Committee Update: Jennifer Bellville - IEA Vice-President and Program Committee Chair	<p>During the last year, the Program Committee has organized 3 Quarterly Meetings:</p> <ul style="list-style-type: none"> • January 18 – Learnings & Resources from AEA with Robert Hoke, Claire Quimby, Jackie Singh, and Jennifer Bellville • April 12 – Indiana Foundations & Evaluation with our foundation panel: Alex Cohen, Ashlee Guthrie, and Dawn Martz, which was moderated by Robert Hoke • July 19 – Lifetime Lessons on Evaluation and Leadership with Mary Williams and Terri Jump <p>Additionally, our Conference Planning Committees – including Programming, Marketing, and Logistics – organized the 2019 IEA Conference on <i>Quality Evaluation</i>, held on October 18th.</p> <ul style="list-style-type: none"> • Keynote speaker <i>Leslie Goodyear</i> shared reflections from her year as AEA President and discussed important issues in evaluation practice in her keynote address – <i>Evaluation Essentials: Evidence, Ethics, and Equity</i> • Concurrent sessions covered a range of evaluation best practices, approaches to communicating findings, data collection and metrics, data visualization, stakeholder engagement strategies, and quantitative and qualitative methodologies.

And we have sent Jackie Singh as an IEA speaker to the Chicagoland Evaluation Association and the Evaluation Association of St. Louis.</p> <p>This coming year, the Program Committee will be organizing 4 Quarterly Meetings.
